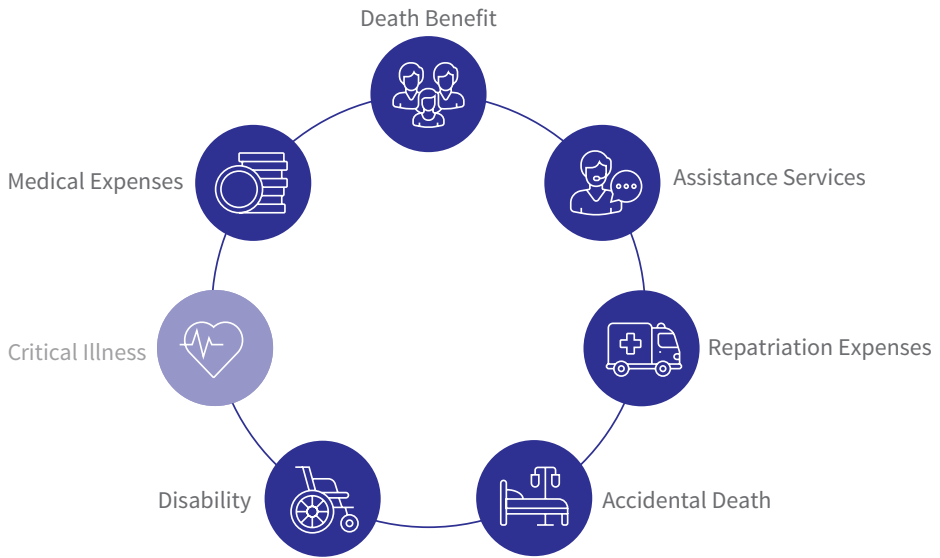
Protection for Real Life - Critical Illness
